### Spokane County Water Resource Center Presentation & Tour

Our September event includes a presentation by Rob Lindsay including an overview of the status of water quality challenges in the Spokane River and the associated community responses, and will then focus on the efforts of the County to address those water quality challenges. 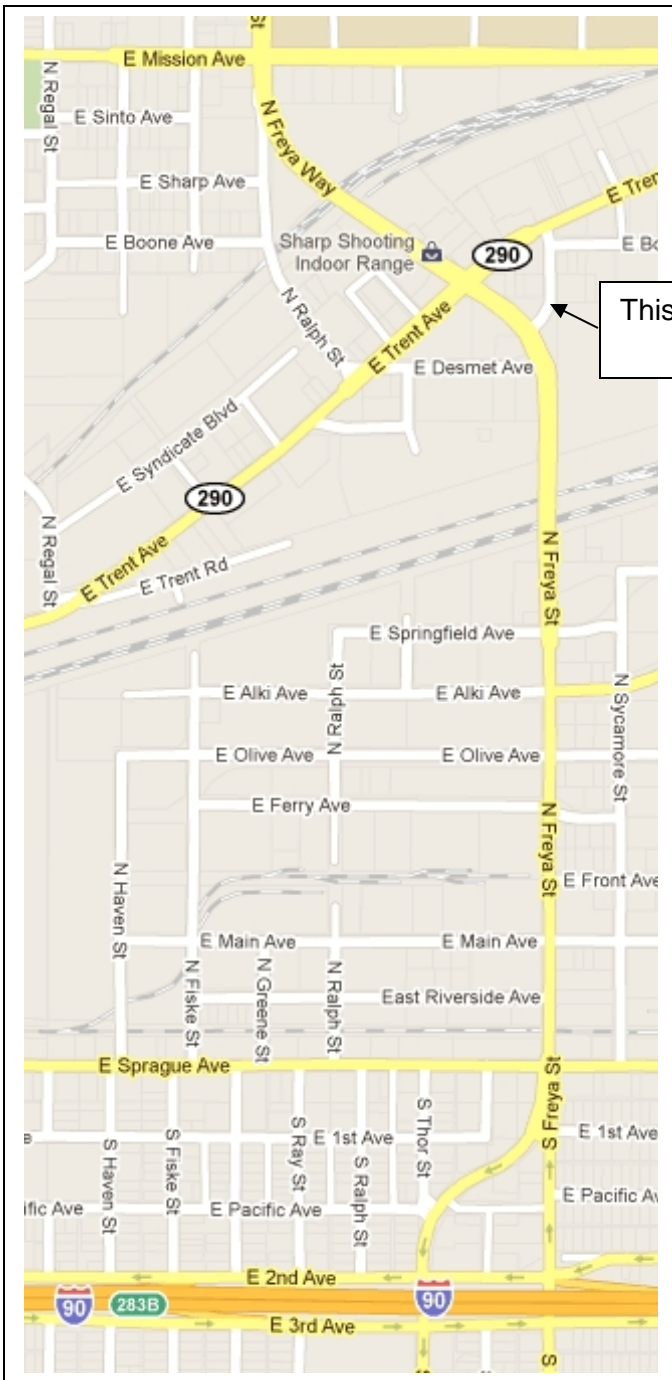

**Directions to the Spokane County Water  
Resource Center (WRC)**  
**1004 N. Freya Street:**

From I-90 (east or west): Take the Freya Exit and head north on N. Freya Street. Cross the bridge over the RR tracks and you will see the Spokane County Water Reclamation Facility to your right.

Immediately after the bridge N. Freya St. sweeps to the left, becoming N. Freya Way; get into the right lane and turn right onto N. Freya St. The entrance to the Water Reclamation Facility and WRC is immediately on your right.
